The appointees shall report to the Joint Director, Geology and Mining Department, Kashmir at Srinagar within a period of 21 days from the date of issuance of this order for further posting in the Districts indicated against each and shall be allowed to join only on production of the following documents / certificates (in original) to be verified subsequently.

**Academic/Technical Qualification Certificate(s):-**

- (i) Matriculation/Date of Birth Certificate;
- (ii) Domicile Certificate issued by the Competent Authority;
- (iii) Health Certificate issued by the concerned Chief Medical Officer of the district;
- (iv) Valid relevant Category Certificate, if any applicable.
- (v) Migration Certificate from the competent authority, where-under, candidate becomes eligible for seeking employment under Hon'ble Prime Minister's Special Package for Kashmiri Migrants; and
- (vi) Any other document(s) as required under rules.

Further, the appointment of above candidates shall be subject to the following conditions:-

- a. That, appointee(s) shall give an Undertaking in the shape of an Affidavit attested by the Judicial Magistrate 1<sup>st</sup> Class on a format attached with this appointment order **(Annexure-A)**.
- b. That, if the appointee has taken loan for self employment from DIC/Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment & Counseling Centre of the domicile district, he shall relinquish the proprietorship of the unit/enterprise and also stakes, if any, in such self-employed unit/enterprise before joining the Government service. He shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such a self-employment unit/enterprise and recovery to be made and also personally monitor its recovery.
- c. The salary of the appointee(s) shall not be drawn and disbursed to them unless satisfactory reports in respect of genuineness of Qualifications/Date of Birth/Relevant Category Certificate are received from the concerned Authorities/Agencies.
- d. The clause (iii) & (iv) of the Government Order No. 58-DMRR&R of 2017 dated 29-07-2017 will regulate the disbursement of salaries of the appointee(s).
- e. The appointees shall be on probation for a period of two years.
- f. The post shall be supernumerary and appointments against these posts are made in terms of J&K Kashmiri Migrants (Special Drive) Recruitment Rules, 2009 and borne under Security Related Expenditure.
- g. In case, **the appointee migrates from Kashmir Valley** at any time during his/her service tenure for any reason what so ever, his/her appointment/service shall **stand terminated without any notice**, itself by the action of his/her migration.
- h. The appointment of the candidate(s) shall be governed by the "New Pension Scheme" as notified vide SRO-400 of 2009 dated 24-12-2009.


- i. If the appointee fails to join within a period of 21 (twenty-one) days from the date of issuance of this order he/she shall forego his/her right to appointment which shall be deemed to have been cancelled *ab-initio* without any further notice.
- j. The appointee shall have to execute an **Agreement** in terms of J&K Kashmiri Migrants (Special Drive) Recruitment Rules, 2009 issued vide **SRO-412 of 2009 dated 30-12-2009** read with SRO-425 dated 10-10-2017 (**Annexure-B**).
- k. The inter-se seniority of the appointee shall be as per the merit as it exists in the selection list prepared by the J&K Service Selection Board;
- l. The appointment shall be subject to outcome of writ petition(s), if any, pending before any Competent Court(s) of Law or any order which may not be presently within the knowledge of this Directorate.

WHEREAS if the appointee/ contracting party willfully neglects or refuses to perform duty in Kashmir Valley the appointing authority shall immediately terminate his service, and

WHEREAS the I/appointee/ contracting party will at no stage seek or opt for transfer outside the Kashmir Valley.
