4. The appointment of the appointee, shall further be subject to the following conditions:-

- (a) That she shall give an undertaking in the shape of an Affidavit attested by the Judicial Magistrate 1st Class to the effect that, if, on verification, genuineness of the qualification certificates from the concerned issuing authority is found that the same is fake / forged, the claim of the appointee for appointment as **Multitasking Staff (Mineral Guard)** shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against her.
- (b) The salary of the appointee shall not be drawn and disbursed to her unless a satisfactory report in respect of (a) above is received in her favour.
- (c) The appointee shall be initially on probation for a period of two years.
- (d) The appointment of the candidate shall be governed by the "New Pension Scheme" as notified vide SRO 400 of 2009 dated 24-12-2009.
- (e) If the appointee fails to join within a period of 21 (Twenty-One) days from the date of issuance of this order she shall forego her right to appointment which shall be deemed to have been cancelled ab-initio without any further notice.
- (f) This Order is issued in pursuance to Rule 18 (C) of the J&K Rehabilitation Assistance Scheme, 2022 issued vide S.O. 429 dated 06-09-2022.
