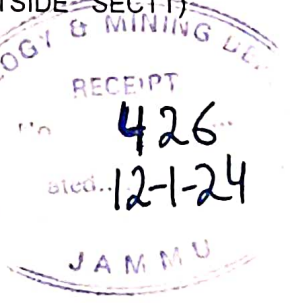

In pursuance to Administrative Department Communication No. GM-MNG/260/2021-04 dated 10-11-2023 followed by General Administration Department's OM No. GAD-SRO-43/CID/2024 dated 04-01-2024, sanction is hereby accorded to the temporary appointment of Sh. Rakesh Kumar S/o Late Sh. Kewal Krishan (Ex-Orderly) R/o Kotla, District Reasi in terms of SRO-43 of 1994 against the post of Multitasking Staff (Mineral Guard) in the Pay Scale of SL1 (14800-47100) under J&K Compassionate Appointment Rules, 1994 issued vide SRO 43 of 1994 (relaxation in qualification bar), after receipt of satisfactory verification report from Spl. Director General CID, J&K, through EVS portal vide Form No. 88436 dated 20-11-2023 duly forwarded by the General Administration Department vide GAD-SRO-43/CID/2023 dated 23-11-2023, for further deployment in District Mineral Office, Reasi.

2. The appointee shall report in the Office of Joint Director, Geology and Mining Department, Jammu within a period of 21 days from the date of issuance of this Order, failing which he shall forego his right to appointment, and the same shall be deemed to have been cancelled ab-initio without any further Notice.

3. The appointee shall be allowed to join only on production of the following Documents / Certificates (in original) to be verified subsequently.

- (i) Academic / Technical Qualification Certificate.
- (ii) Date of Birth Certificate.
- (iii) Domicile Certificate.
- (iv) Health Certificate issued by concerned Chief Medical Officer of the District.
- (v) No Loan Certificate under Self Employment Scheme from DIC concerned and Employment Department.
- (vi) Valid Reservation Certificate issued by the competent authority, if any.
- (vii) All other relevant documents as required under SRO 43/1994.

4. The appointment of the appointee, shall further be subject to the following conditions:-
- (a) That he shall give an undertaking in the shape of an Affidavit attested by the Judicial Magistrate 1st Class to the effect that, if, on verification, genuineness of the qualification certificates from the concerned issuing authority is found that the same is fake / forged, the claim of the appointee for appointment as **Multitasking Staff (Mineral Guard)** shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against him.
 - (b) The salary of the appointee shall not be drawn and disbursed to him unless a satisfactory report in respect of (a) above is received in his favour.
 - (c) The appointee shall be initially on probation for a period of two years.
 - (d) The appointment of the candidate shall be governed by the "New Pension Scheme" as notified vide SRO 400 of 2009 dated 24-12-2009.
 - (e) If the appointee fails to join within a period of 21 (Twenty-One) days from the date of issuance of this order, he shall forego his right to appointment which shall be deemed to have been cancelled ab-initio without any further notice.
 - (f) This Order is issued in pursuance to Rule 18 (C) of the J&K Rehabilitation Assistance Scheme, 2022 issued vide S.O. 429 dated 06-09-2022.

The appointment of the above appointee shall be subject to outcome of writ petition(s), if any, pending before any Competent Court(s) of Law.
