**Subject:- Minor Mineral Block in District, Ramban - Letter of Intent (LoI) for grant of Quarry License for Minor Minerals under the Jammu and Kashmir Minor Mineral Concession, Storage, Transportation of Minerals and Prevention of Illegal Mining Rules, 2016.**

**Whereas,** M/S Age Patel (JV) applied for grant of Quarry License alongwith Site Plan on 05.02.2021 at Village Seri Puri Baralla, Sangaldan, Ramban over an area of 0.475 hectares; and

**Whereas,** the Joint Director(J) Geology and Mining Department, Jammu vide letter No.JDJ/Age Patel(JV) 2018-19/92-93 dated 6.4.2021 informed that M/S Age Patel applied for grant of Short Term Permit on the said area duly recommended by District Mineral Officer, Ramban vide No. DMO/ RBN/ 2020-21/Age-Patel/141-42 dated 23.02.2021; and

**Whereas,** the proposal vide No. JDJ/Age Patel(JV) 2018-19/92-93 dated 6.4.2021 of Joint Director(J) Geology and Mining Department, Jammu was submitted to Administrative Department(Mining) vide this office letter No. 987/MCC/DGM/STP/AGP/20/804-05 dated 7.4.2021 for accord of necessary approval for consideration of the case over an area of 0.475 hectares Village Seri Puri Baralla, Sangaldan, Ramban under Rule-56 of SRO-105 dated 31.03.2021 amended vide S.O No.345 dated 13.11.2020 read with S.O No. 391 dated 22.12.2020 for Short Term Permit in favour of the Principal Executing Agency of M/S Ircon International Ltd., i.e M/s Age Patel(JV) and approval was conveyed by Administrative Department(Mining) vide No. IND/MNG/47/2020 dated 9.4.2021 ; and

**Whereas,** the Short Term Permit was issued by Joint Director(J) Geology and Mining Department for the said area in favour of M/s Age Patel(JV) vide



No. Jt/DGM/Age-Patel/2018-19/118-124 dated 9.4.2021 and the firm was working on Short Term Permit on the said area; and

**Whereas**, the Geo-referenced Site Plan of the above applied area of 0.475 hectares with corner points "A,B,C,D,E,F,G,A" falls in Forest land and sanction has been granted by the Department of Forest, Environment & Ecology, Civil Secretariat, J&K(UT) vide Government Order No. 263-FST of 2018 dated 09.08.2018 for use of the said area 0.475 hectares for construction of balance work to Tunnel T-14 and Tunnel T-15 and Bridge No. 61 USBRL Project by Age-Patel Joint Venture in Comptt. No. 52/Ar Tehsil, Gool in Mahore Forest Division for quarry purpose; and

**Whereas**, M/S Age Patel (JV) requested vide letter No.100/351/ USBRL-T15/P&A/1847 dated 08.10.2021 for grant of Quarry License.

**Now**, therefore in view of the above and as per Chapter-V, Rule 43 & 55(9) of the Jammu and Kashmir Minor Mineral Concession, Storage, Transportation of Minerals and Prevention of Illegal Mining Rules, 2016, the Letter of Intent (LoI) is hereby issued with the direction to submit Approved Mining Plan, Environmental Clearance besides, deposition of Application fees of Rs. 5,000/-(Demand Draft), Security Deposit amounting to Rs. 50,000/-(CDR), Quarterly Dead Rent of Rs. 3500/-(CDR), Financial Assurance amounting to Rs.1.00 lacs in the shape of Bank Guarantee and Consent to Operate from J&K Pollution Control Committee within a period of 01 Year, enabling this office to grant Quarry License in your favour for extraction of minor minerals from the above said block. You shall not extract or allow extraction till the Quarry License under rules is granted.

*This Letter of Intent (LoI) is provisional. This shall be further subject to obtaining NOC from Stake holder departments/any other requirement/ statutory clearance under any Law/Rules governing the subject.*
