**Whereas**, the Adm. Department (I&C) scrapped the open auction process vide communication No. IND/Legal/239/2018 dated 26.02.2019 & subsequently various Writ Petitions challenging the said scrapping were dismissed by the Hon'ble High court in its judgment dated 01.05.2020, LPAs filed against these being well contested in the Double Bench of the Hon'ble High court.

**Whereas**, subsequently Government vide its Order No. 95-IND of 2020 dated 27.05.2020 has allotted/reserved Minor Mineral Block No-01 over an area of 4.24 hectares at Tawi River Upstream Salmaya Bridge District, Udhampur in favour of M/S J&K Minerals Ltd.

**Whereas**, the Corporation submitted the approved Mining Plan on 06.08.2020 duly approved by Competent Authority vide No.DGM/DD(MI)/T.S/MP-Udh/2020-21/1837-42 dated 24.06.2020;

**Whereas**, the Corporation submitted the Environmental Clearance on 28.07.2020 granted by J&KEIAA vide No. JKEIAA/2020/206/560-67 dated 24.07.2020;

**Whereas**, the Corporation submitted Consent to Establish on 28.07.2020 issued by J&K Pollution Control Board vide No. PCB/digital/20011569872 of 2020 dated 27.07.2020 ;

**Whereas**, the Corporation submitted Consent to Operate on 6.08.2020 issued by J&K Pollution Control Board vide No. PCB/digital/20041570944 of 2020 dated 4.08.2020;


**Whereas**, the Corporation submitted Memorandum and Article of Association on 6.08.2020;

Therefore, in exercise of the powers vested with Director Geology & Mining under Rule 42 of the J&K Minor Mineral Concession, Storage, Transportation of Minerals and Prevention of Illegal Mining Rules, 2016 sanction is hereby accorded to grant of Mining lease of Minor Mineral Block No-01, over an area of 4.24 hectares at Tawi River Upstream Salmaya Bridge District, Udhampur in favour of M/S J&K

Minerals Ltd. for a period of 05 years subject to the following terms and conditions that :-

1. The lessee shall have no objection to the conducting of exploration in the leased area as and when required by the Department.
2. The lessee shall abide by the provisions of Mines & Minerals (Development & Regulation) Act, 1957 and Rules made thereunder.
3. The lessee shall execute, register the lease deed as per Rule, 40 of the J&K Minor Mineral Concession, Storage, Transportation of Minerals and Prevention of Illegal Mining Rules, 2016 with the conditions laid down in Rule 38 of the said Rules.
4. The lessee shall furnish Financial Assurance in the shape of Bank Guarantee favouring Director, Geology & Mining for restoration/reclamation works as per the Mining Plan.
5. The lessee shall commence the mining operation only after demarcation of the lease area by the Department.
6. The lessee shall not further sublet the Mining Lease.
7. The Lessee shall work as per mandate prescribed in Govt; Order No 95-IND of 2020 dated 27.05.2020.
8. The Lessee shall work strictly as per approved Mining Plan and guidelines/Conditions of Environmental Clearance/CTE/CTO.
9. The lessee shall adhere the instructions of MoEF&CC, NGT, Stake Holder Departments & District Administration etc. issued from time to time.
