**Subject:- E-Auction of Minor Mineral Blocks in District, Kathua - Letter of Intent (LoI) for grant of Mining Lease for Minor Minerals under the Jammu and Kashmir Minor Mineral Concession, Storage, Transportation of Minerals and Prevention of Illegal Mining Rules, 2016.**

**Whereas**, E-Auction of approved **Minor Mineral Block- 24** with the description, **Jothana-Di-Khad at village Janal, Plan-I Distt., Kathua** covering an area of **3.81 hectares** with Geo-coordinates of corner (A= 32° 31'30.13"N 75° 28'7.08"E, B=32° 31'24.75"N 75° 28'3.24"E, C=32° 31'21.51"N 75° 27'59.78"E, D=32° 31'24.35"N 75° 27'58.39"E, E=32° 31'29.58"N 75° 28'1.41"E, F=32° 31'33.58"N 75° 28'4.38"E, G= 32° 31'33.14"N 75° 28'6.86"E) of District, Kathua was conducted by District Auction Committee under the Chairmanship of Deputy Commissioner, Kathua on 27-06-2020;

**Whereas**, Dy. Commissioner, Kathua vide communication No. DCK/SQ/2020-21/312 dated 02.07.2020 has informed that in the E-auction you have emerged as highest bidder in respect of said Minor Mineral Block;

**Whereas**, the highest bid amount to the tune of **Rs. 156.37 lacs** for the said Minor Mineral Block has been accepted by the Chairman District Auction Committee (Dy. Commissioner, Kathua and recommended to the Director, Geology and Mining J&K; for issuance of Letter of Intent(LoI);

**Whereas**, under Rule 26(2), submission of duly approved Mining Plan and Environmental Clearance is mandatory for grant of any Mineral Concession;

**Whereas**, TDS/TCS shall have to be paid by you on offered bid amount as applicable under Income tax Act, 1961 before grant of Mineral Concession;

**Whereas**, J&K Pollution Control Board vide their communication No. SPCB/NGT/60/019/134-37 dated 12.11.2019 has informed that no extraction of the minor minerals shall be allowed from the auctioned blocks unless consented by the J&K PCB under Water(Prevention & Control of Pollution) Act, 1974 and Air(Prevention & Control of Pollution) Act, 1981;

**Whereas**, Call Deposit Receipt No. **301801** dated 30-06-2020 amounting to **Rs 78.185 lacs** & Demand Draft No. **089240** dated 30-06-2020 amounting Rs. 1,56,370/- submitted by you as 50% Bid amount & as 2% Income tax has been received through Deputy Commissioner, Kathua;

**Whereas**, Administrative Department (I&C) vide communication No. IND/MNG/52/2020 dated 31-07-2020 has conveyed the approval to the acceptance of the highest bid offered by you;

**Now**, therefore in view of the above and as per Rule 55(9) of these Rules, the Letter of Intent (LoI) is hereby issued with the direction to submit Approved Mining Plan, Environmental Clearance besides, deposition of remaining 50% bid amount & Consent to Operate within a period of 06 months, enabling this office to grant Mining Lease in your favour for extraction of minor minerals (River Bed Material) from the above said block. You shall not extract or allow extraction till the Mining Lease under rules is granted.

*This Letter of Intent (LoI) is provisional. This shall be further subject to obtaining NOC's/ any other third party dispute/requirement/statutory clearance under any Law/Rules governing the subject.*
