Whereas, under Rule 26(2), submission of duly approved Mining Plan and Environmental Clearance is mandatory for grant of any Mineral Concession;


Whereas, TDS/TCS shall have to be paid by you on offered bid amount as applicable under Income tax Act, 1961 before grant of Mineral Concession;
