Subject:- E-Auction of Minor Mineral Blocks in District, Pulwama - Letter of Intent (LoI) for grant of Mining Lease for Minor Minerals under the Jammu and Kashmir Minor Mineral Concession, Storage, Transportation of Minerals and Prevention of Illegal Mining Rules, 2016.

Whereas, E-Auction of approved **Minor Mineral Block-39** with the description, **E-Newa Diversion bridge Upstream, Nallah Ramshoo** covering an area of **3.18** hectares with Geo-coordinates of corner points (A=33° 54' 22.79" N 74° 53' 15.90" E, B=33° 54' 21.90" N 74° 53' 09.75" E, C=33° 54' 20.10" N 74° 53' 3.96" E, D=33° 54' 14.31" N 74° 52' 55.88" E, E=33° 54' 6.67" N 74° 52' 47.16" E, F=33° 54' 1.00" N 74° 52' 37.98" E, G=33° 54' 1.83" N 74° 52' 36.69" E, H= 33° 54' 12.20" N 74° 52' 51.94" E, I=33° 54' 21.44" N 74° 53' 3.50" E, J=33° 54' 23.85" N 74° 53' 15.69" E) of District, Pulwama was conducted by District Auction Committee under the Chairmanship of Dy. Commissioner, Pulwama on 05.02.2020;

Whereas, Dy. Commissioner, Pulwama vide communication No. 22/DCP/Estt/Auc dated 11.02.2020 read with No. DCP/PA/20/9761 dated 22.06.2020 has informed that in the E-auction you have emerged as highest bidder in respect of said Minor Mineral Block;

Whereas, the highest bid amount to the tune of **Rs. 236.10 lacs** for the said Minor Mineral Block has been accepted by the Chairman District Auction Committee (Dy. Commissioner, Pulwama) and recommended to the Director, Geology and Mining J&K; for issuance of Letter of Intent(LoI);

Whereas, under Rule 26(2), submission of duly approved Mining Plan and Environmental Clearance is mandatory for grant of any Mineral Concession;

Whereas, TDS/TCS shall have to be paid by you on offered bid amount as applicable under Income Tax Act, 1961 before grant of Mineral Concession;

Whereas, J&K Pollution Control Board vide their communication No. SPCB/NGT/60/019/134-37 dated 12.11.2019 has informed that no extraction of the minor minerals shall be allowed from the auctioned blocks unless consented by the J&K PCB under Water(Prevention & Control of Pollution) Act, 1974 and Air(Prevention & Control of Pollution) Act, 1981;

Whereas, Term Deposit Receipt(TDR) No.919307 dated **07.02.2020** amounting to Rs. **118.05** lacs submitted by you as 50% Bid amount has been received through Deputy Commissioner, Pulwama;

Whereas, the Adm. Department (I&C) vide communication No. IND/MNG-46/2020 dated 02.07.2020 has conveyed the approval to the acceptance of highest bid offered by you & with the condition that before formal allotment by the Directorate of Geology and Mining Department J&K, pegging shall be done by the team of Geology and Mining Department and Revenue Department in presence of the allottee;

Now, therefore in view of the above and as per Rule 55(9) of these Rules, the Letter of Intent (LoI) is hereby issued with the direction to submit Approved Mining Plan, Environmental Clearance besides, deposition of remaining 50% bid amount & Consent to Operate within a period of 06 months, enabling this office to grant Mining Lease in your favour for extraction of minor minerals (River Bed Material) from the above said block. You shall not extract or allow extraction till the Mining Lease under rules is granted.

This Letter of Intent (LoI) is provisional. This shall be further subject to obtaining NOC from Stake Holder Departments/any other clearance requirement/statutory under any Law/Rules governing the subject.
