**ORDER**

Pursuant to the recommendations of Service Selection Board, J&K, Jammu/Srinagar vide above referred communications and as forwarded and communicated by the Administrative Department (I&C), sanction is hereby accorded to the appointment of the following candidate against the post of Junior Assistant cum Computer Operator (District Cadre Srinagar) in the pay scale of Level 4 (25500-81100) (Rs. 5200-20200+2400 GP) (pre-revised) in terms of SRO 333 dated 02-08-2018.

2. The appointee shall report in the office of Joint Director (K), Geology and Mining Department, Srinagar within a period of 21 days from the date of issuance of this order for further posting in District Srinagar and shall be allowed to join only on production of the following documents / certificates to be verified subsequently.

- (i) Academic / Technical Qualification Certificate;
- (ii) Date of Birth Certificate;
- (iii) Domicile Certificate.
- (iv) Health Certificate issued by concerned Chief Medical Officer of the District;
- (v) Character and Antecedents Certificate as required under rules;
- (vi) No Loan Certificate under Self Employment Scheme from DIC concerned and Employment Department;
- (vii) Valid Reservation Certificate issued by the competent authority, if any;
- (viii) The appointee shall have to execute an agreement in terms of J&K Kashmiri Migrants (Special Drive) Recruitment Rules, 2009 issued vide SRO 412 of 2009 dt. 30-12-2009 read with SRO 425 dt. 10-10-2017.
- (ix) Affidavit & Undertaking duly attested by the Judicial Magistrate 1<sup>st</sup> Class on the devised format enclosed with appointment order;
- (x) The appointee shall also give the attestation Form as per Annexure-1 accompanied by an undertaking prescribed in Annexure-IV of Government order No. 1328-GAD of 2016 dated 07-12-2016;
- (xi) Migration Certificate from the competent authority, where-under, eligible for seeking employment under Hon'ble Prime Minister Special Package for Kashmiri Migrants;
- (xii) All other documents as required under rules;

3. The appointment of the appointee shall further be subject to the following conditions:-

- (a) That he/she shall give an undertaking in the shape of an Affidavit to the effect that:
  - (i) In case adverse report about his/her Character and Antecedents is received from the Inspector General of Police, (CID), J&K, to whom a reference shall be made by the Joint Director, Kashmir, he/she shall have no right to claim his/her appointment as Junior Assistant cum Computer Operator in Geology and Mining Department and his/her appointment, as such, shall be deemed to have been cancelled *ab-initio*;
  - (ii) If, on verification, genuineness of the qualification certificates from the concerned issuing authority is found that the same is fake / forged, the claim of the appointee for appointment as Junior Assistant cum Computer Operator shall also be deemed to have been cancelled *ab-initio* and the legal action as warranted under rules shall be initiated against him/her.
- (b) The appointee shall be initially on probation for a period of two years.
- (c) The salary of the appointee shall not be drawn and disbursed to his/her unless a satisfactory report in respect of (i) and (ii) above are received in his/her favour.
- (d) The clause (iii) & (iv) of the Government order No. 58-DMRR&R of 2017 dated 29-07-2017 will regulate the disbursement of salaries of the employee.



- (e) The post shall be supernumerary and appointments against these posts are made in terms of J&K Kashmiri Migrants (Special Drive) Recruitment Rules, 2009 and borne under Security Related Expenditure.
- (f) In case, the appointee migrates from Kashmir Valley at any time during his/her service tenure for any reason what so ever, his/her appointment/service shall stand terminated without any notice, itself by the action of his/her migration.
- (g) The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 dated 24-12-2009.
- (h) If the appointee fails to join within a period of 21 (twenty one) days from the date of issuance of this order he/she shall forego his/her right to appointment which shall be deemed to have been cancelled *ab-initio* without any further notice.
- (i) This order is issued without prejudice to writ petition(s)/suit, if any, pending/sub-judice before the Hon'ble High Court or any other Court of Law or any order which may not be presently within the knowledge of this Directorate.

WHEREAS if the appointee willfully neglects or refuses to perform his duty in Kashmir Valley the appointing authority shall immediately terminate his service' and

WHEREAS the appointee will at no stage seek or opt for transfer outside the Kashmir Valley.
