For and on the behalf of Lt. Governor, UT of Jammu & Kashmir – e-Bids are hereby invited from the original equipment manufacturers (OEM), their authorized distributors/dealers/suppliers for the supply of 02 No. Handheld XRF Analyzer alongwith training of the instrument.

Bidders are advised to study the Bid Documents carefully before the submission of their e-Bid. Submission of e-Bid shall be deemed to have been done after careful study and examination of the procedures, terms and conditions & specifications provided in Bid Documents. e-Tender Document shall be available on website <http://jktenders.gov.in> as per schedule of events given below.

Interested bidders may view, download the e-Tender document, seek clarification if any and submit their e-Bid online as per the schedule of events.

The bidders need to submit Bid Processing Fee (Non-Refundable) of Rs. 500.00 through Treasury Receipt (TR)/Treasury Challan or Demand Draft of any nationalized/scheduled Bank pledged to Director, Directorate of Geology & Mining, Jammu & Kashmir payable at Jammu. The scanned copy of Treasury Receipt (TR)/Treasury Challan or Demand Draft must be enclosed alongwith the e-Bids but the original should reach the office of the Director, Directorate of Geology & Mining, Jammu & Kashmir, Jammu before opening of the e-Tender. Bid Processing Fee shall be exempted in case of MSME/Start Up's as per rules.

The bidders need to submit EMD of Rs. 38,000.00. All the e-Bids must be accompanied by the scanned copy of EMD in the form of Demand Draft issued by a nationalized/scheduled Bank only, pledged to the Director, Directorate of Geology & Mining, Jammu & Kashmir and payable at Jammu. EMD in original should reach to the office of the Director, Directorate of Geology & Mining, Jammu & Kashmir before opening of the e-Tender. E-Bids received without EMD will be summarily rejected. EMD shall be exempted in case of MSME/Start Up's as per rules. In case of un-successful bidders, EMD will be refunded at an earliest.

The e-Bids (Technical & Financial) will be opened online in Directorate of Geology & Mining, Jammu & Kashmir, Jammu in presence of bidder's/bidder's representatives, who choose to attend as per date and time mentioned in schedule of events. In case of the representative attending the opening of the e-Bid, authority letter of the bidder will be required to be produced.

The Department reserves the right to cancel the e-Bids/e-Bid process anytime without assigning any reason thereof. The decision of the Department will be final and binding to all.

In the event of date specified for e-Bids opening being a holiday/declared a holiday, e-Bids shall be opened on the following working day.

All the required documents should be uploaded by the Bidder electronically, whereas Price Schedule/BOQ should be uploaded by the Bidder electronically in the same BOQ sheet provided with the e-Tender.
