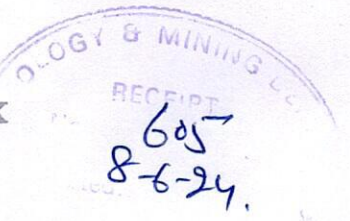

**Subject:** Transfer of Mining Lease of **Minor Mineral Block No.-10** with the description, Panzan Bridge to Dregam Upstream Shailganga Nallah, District Budgam in favour of **Sh. Ishtiyaq Ahmad Dar.**

**Whereas,** the Mining Lease of **Minor Mineral Block No.10, over an area of 4.85 hectares,** located at Panzan Bridge to Dregam Upstream Shailganga Nallah, District Budgam was granted vide this office Order No. **121-DGM of 2021, dated 09.09.2021** in favour of **Mr. Abdul Rashid Mir S/o Sh. Ghulam Ahmad Mir R/o 99-Markazi, Jamal Masjid, Rawalpora, Beeru, Budgam** for a period of 05 years, and the validity period in terms of Rule-41 of SRO-105 of 2016 starts from the date of registration of Mining lease i.e. 01.11.2021 in the instant case;

**And whereas,** Mr. Abdul Rashid Mir, the Mining lessee of the above said Minor Mineral Block, vide his application dated 07.05.2024 applied for transfer of Mining lease in terms of Rule-37 of *The Jammu & Kashmir Minor Mineral Concession, Storage, Transportation of Minerals and Prevention of Illegal Mining Rules, 2016 (SRO-105 of 2016)*, in favour of **Mr. Ishtiyaq Ahmad Dar** and have also submitted a *Demand Draft No.299119, dated 04.05.2024 of Rs.50,000/- (Rupees Fifty Thousand Only)* as processing fees for the transfer of Mining Lease. Further, Mr. Abdul Rashid Mir has also given an undertaking dated 01.06.2024 stating therein that he has taken the consideration amount from Mr. Ishtiyaq Ahmad Dar in lieu of the transfer of Mining lease in favour of the latter;

**And whereas,** the Joint Director, Geology & Mining, Kashmir vide his office No.MSK/DGM/Sgr/F-10/Bud/736, dated **30.05.2024** have also certified that the conditions envisaged under Rule-37(2)(i)&(ii) with regard to: **(i)** the instant lease having remained in force for atleast two years from the date of its grant; and **(ii)** that no dues are outstanding against the transferor or the transferee, are fulfilled;

**Now therefore,** in terms of Rule-37 and in exercise of the powers vested in the undersigned under Rule-42 of SRO-105 of 2016, sanction is hereby accorded to the transfer of Mining lease of the **Minor Mineral Block No.10,** spread over an area of **4.85 hectares,** with the description, **Panzan Bridge to Dregam Upstream Shailganga Nallah, District Budgam** in favour of **Sh. Ishtiyaq Ahmad Dar S/o Mohammad Ramzan Dar R/o Buchpora Srinagar** on the same terms and conditions as were laid down in **Order No. 121-DGM of 2021, dated 09.09.2021** and as per other applicable rules/laws governing the subject. The Mining Lease transferred shall be for remaining period i.e. till expiry of the lease.

It is further ordered that the transferor and transferee shall execute the transfer deed of the **Mining lease of Minor Mineral Block No.10** in prescribed form ML-6 within a period of **90 (Ninety) days** from the issuance of this order and submit a copy of duly registered/executed transfer deed to this Directorate.
