ORDER NO: 276-DGM of 2024 Dated: 08.06.2024

Subject: Transfer of Mining Lease of Minor Mineral Block No-34 with the description, Thanda Seri Khad at village Tanda, District, Reasi in favour of M/S Choudhary Power Projects Pvt. Ltd.

Whereas, the Mining Lease of Minor Mineral Block No.34, over an area of 8.49 hectares, located at 'Thanda Seri Khad at village Tanda, District, Reas' was granted vide this office Order No.107-DGM of 2021, dated 28.08.2021 in favour of Mr. Mangal Singh S/o Sh. Om Parkash R/o Village Saidgarh Tehsil, Bishnah, Jammu for a period of 05 years, and the validity period in terms of Rule-41 of SRO-105 of 2016 starts from the date of registration of Mining lease i.e. 30.09.2021 in the instant case;

And whereas, Mr. Mangal Singh, the Mining lessee of the above said Minor Mineral Block, vide his Application No. TF/2023-24/832, dated 13.09.2023 applied for transfer of Mining lease in terms of Rule-37 of The Jammu & Kashmir Minor Mineral Concession, Storage, Transportation of Minerals and Prevention of Illegal Mining Rules, 2016 (SRO-105 of 2016), in favour of M/S Choudhary Power Projects Pvt. Ltd. and have also submitted a Demand Draft No.840750, dated 16.09.2023 of Rs.50,000/-(Rupees Fifty Thousand Only) as processing fees for the transfer of Mining Lease. Further, Mr. Mangal Singh has also given an undertaking dated 05.01.2024 stating therein that he has taken the consideration amount from M/S Choudhary Power Projects Pvt. Ltd. in lieu of the transfer of Mining lease in favour of the latter;

And whereas, the Joint Director, Geology & Mining, Jammu vide his office No. JDJ/MMB-34/Reasi/2023-24/517, dated 17.05.2024 read with Letter No. JDJ/MMB-34/Reasi/2023-24/773, dated 08.06.2024 have also certified that the conditions envisaged under Rule-37(2)(i)&(ii) with regard to: (i) the instant lease having remained in force for atleast two years from the date of its grant; and (ii) that no dues are outstanding against the transferor or the transferee, are fulfilled;

Now therefore, in terms of Rule-37 and in exercise of the powers vested in the undersigned under Rule-42 of SRO-105 of 2016, sanction is hereby accorded to the transfer of Mining lease of the Minor Mineral Block No.34, spread over an area of 8.49 hectares, with the description, Thanda Seri Khad at village Tanda, District, Reasi' in favour of M/S Choudhary Power Projects Pvt. Ltd. on the same terms and conditions as were laid down in Order No. 107-DGM of 2021, dated 28.08.2021 and as per other applicable rules/laws governing the subject. The Mining Lease transferred shall be for remaining period i.e. till expiry of the lease.

It is further ordered that the transferor and transferee shall execute the transfer deed of the *Mining* lease of Minor Mineral Block No.34 in prescribed form ML-6 within a period of 90 (Ninety) days from the issuance of this order and submit a copy of duly registered/executed transfer deed to this Directorate.
