Subject: - Construction of Standalone Ring Road/Bypass around Srinagar city Phase-I in the Jammu and Kashmir UT from Galandar (KM 0.00 to Crossing Sumbal Road (KM 42.100) under NHDP phase-VII: Request for allotment of Quarry for mining of Boulder, RBM, Sand and Bajri/ Nalla Bajri.

Order

In terms of Rule-91 of J&K Minor Mineral Concession, Storage, Transportation of Minerals and Prevention of Illegal Mining Rules 2016, the minor mineral block with the description Driegam Bridge Downstream Shaliganga Nallah, District Budgam over an area 3.17 hectare with corner points ABCDEFGHIJKLMNOP (the limits whereof are specifically described in the enclosed Geo-referenced site plan: A= N 33°56'44.91"/ E 74°43'34.47" B= N 33°56'46.38"/ E 74°43'38.73" C= N 33°56'50.18"/ E 74°43'43.49" D= N 33°56'54.68"/ E 74°43'45.25" E= N 33°56'59.03"/ E 74°43'49.61" F= N 33°57'01.42"/ E 74°43'53.86" G= N 33°57'03.86"/ E 74°44'06.10" H= N 33°57'04.29"/ E 74°44'14.34" I= N 33°57'03.12"/ E 74°44'15.08" J= N 33°57'03.01"/ E 74°44'05.88" K= N 33°57'00.49"/ E 74°43'53.95" L= N 33°56'58.63"/ E 74°43'49.84" M= N 33°56'54.41"/ E 74°43'46.45" N= N 33°56'49.79"/ E 74°43'44.59" O= N 33°56'45.88"/ E 74°43'39.07" P= N 33°56'44.39"/ E 74°43'34.74") is hereby reserved for the allotment of quarry in favour of National Highways Authority of India for exploitation of minor minerals such as Boulders, RBM, Sand and Nalla Bajri to be used in construction of Standalone Ring Road/Bypass project around Srinagar City, J&K (UT) under NHDP Phase-VII by M/S NKC Project Private Limited which is Principal Executive Agency of NHAI. This case for reserving minor mineral block for allotment of quarry has been recommended by Joint Director, Geology & Mining Department, Kashmir vide letter No.MSK/DGM/SGR/F-STP-Bud-01A/4542 dated 12.8.2021 and District Mineral Officer, Budgam vide No. DMO/BUD/DGM/819 dated 9.8.2021 along with letter of Deputy Commissioner, Budgam vide No. Geology, Mining/4932-39 dated 9.8.2021 forwarding above said Site Plan of minor mineral block identified by the M/S NKC Projects Pvt. Ltd., and the NOC/Clearances/Title verification from the stake holding departments issued through District Level Single Window Clearance Committee.

The exploitation in the above said Minor Mineral Block shall be subject to execution of Quarry License Lease deed under Rules. M/S NKC Projects Pvt. Ltd. Principal Executing Agency of NHAI shall obtain all the statutory clearances viz approved Mining Plan, Environmental Clearance & Consent to Operate from Competent Authority etc. as prescribed under

SRO-105 dated 31.03.2016 for grant of Mineral Concession in their favour. Besides, they shall not sub-let the said Minor Mineral Block to any individual/firm/company etc.
