Whereas, E-Auction of approved **Minor Mineral Block-25** with the description, **Sheikhpura Trenz bridge D/Stream Nallah Rambhara District, Shopian** covering an area of **9.12 hectares** with Geo-coordinates of corner points (A=33° 46' 44.24" N 74° 53' 34.24" E, B=33° 46' 46.07" N 74° 53' 38.18" E, C=33° 46' 51.21" N 74° 53' 49.11" E, D=33° 46' 44.98" N 74° 53' 53.64" E, E=33° 46' 38.74" N 74° 53' 39.10" E) of District, Shopian was conducted by District Auction Committee under the Chairmanship of Dy. Commissioner, Shopian on **04.03.2020**;

Whereas, Dy. Commissioner, Shopian vide communication No. **DCS/PA/2020/7440(A)** dated **07.03.2020** has informed that in the E-auction you have emerged as highest bidder in respect of said Minor Mineral Block;

Whereas, the highest bid amount to the tune of **Rs. 25.70 lacs** for the said Minor Mineral Block has been accepted by the Chairman District Auction Committee (Dy. Commissioner, Shopian) and recommended to the Director, Geology and Mining J&K; for issuance of Letter of Intent(LoI);

Whereas, under Rule 26(2), submission of duly approved Mining Plan and Environmental Clearance is mandatory for grant of any Mineral Concession;

Whereas, TDS/TCS shall have to be paid by you on offered bid amount as applicable under Income Tax Act, 1961 before grant of Mineral Concession.

Whereas, J&K Pollution Control Board vide their communication No. SPCB/NGT/60/019/134-37 dated 12.11.2019 has informed that no extraction of the minor minerals shall be allowed from the auctioned blocks unless consented by the J&K PCB under Water(Prevention & Control of Pollution) Act, 1974 and Air(Prevention & Control of Pollution) Act, 1981;

Whereas, Term Deposit Receipt (TDR) No. **019770** dated **06.03.2020** amounting to **Rs.12.85 lacs** submitted by you as 50% Bid amount has been received through Deputy Commissioner, Shopian;

Now, therefore in view of the above and as per Rule 55(9) of these Rules, the Letter of Intent (LoI) is hereby issued with the direction to submit Approved Mining Plan, Environmental Clearance besides, deposition of remaining 50% bid amount & Consent to Operate within a period of 06 months, enabling this office to grant Mining Lease in your favour for extraction of minor minerals (River Bed Material) from the above said block. You shall not extract or allow extraction till the Mining Lease under rules is granted.

This Letter of Intent (LoI) is provisional. This shall be further subject to outcome of any Writ Petition, if any/obtaining NOC from Stake Holder Departments/any other requirement/statutory clearance under any Law/Rules governing the subject.
