**Subject:- E-Auction of Minor Mineral Blocks in District, Budgam - Letter of Intent (LoI) for grant of Mining Lease for Minor Minerals under the Jammu and Kashmir Minor Mineral Concession, Storage, Transportation of Minerals and Prevention of Illegal Mining Rules, 2016.**

**Whereas**, E-Auction of approved **Minor Mineral Block 10/Bud** with the description, Panzan Bridge to Dregam Upstream Shailganga Nallah District Budgam covering an area of **10.00 hectares** with Geo-coordinates of corner points (A= 33° 57' 45.61" N 74° 46' 22.91 " E, B= 33° 57' 35.79" N 74° 45' 55.38 " E, C=33° 57' 37.00" N 74° 45' 46.92 " E, D=33° 57' 32.84" N 74° 45' 36.73 " E, E=33° 57' 32.89" N 74° 45' 28.19 " E, F=33° 57' 39.93" N 74° 45' 47.28 " E, G=33° 57' 38.92" N 74° 45' 00.17 " E, H=33° 57' 43.00" N 74° 45' 07.55 " E, I=33° 57' 47.23" N 74° 45' 22.13 "E) of District, Budgam was conducted by District Auction Committee under the Chairmanship of Dy. Commissioner, Budgam on 22.06.2020;

**Whereas**, Dy. Commissioner, Budgam vide communication No. DMO/BUD/DGM/F-05/1195-97 dated 27.06.2020 read with DMO/BUD/DGM/F-5/1331 dated 07-09-2020 and 1344-45 dated 09-09-2020 has informed that in the E-auction you have emerged as highest bidder in respect of said Minor Mineral Block;

**Whereas**, the highest bid amount to the tune of **Rs. 130.79 lacs** for the said Minor Mineral Block has been accepted by the Chairman District Auction Committee (Dy. Commissioner, Budgam and recommended to the Director, Geology and Mining J&K; for issuance of Letter of Intent(LoI);

**Whereas**, under Rule 26(2), submission of duly approved Mining Plan and Environmental Clearance is mandatory for grant of any Mineral Concession;


**Whereas**, TDS/TCS shall have to be paid by you on offered bid amount as applicable under Income tax Act, 1961 before grant of Mineral Concession;

**Whereas**, J&K Pollution Control Board vide their communication No. SPCB/NGT/60/019/134-37 dated 12.11.2019 has informed that no extraction of the minor minerals shall be allowed from the auctioned blocks unless consented by the J&K PCB under Water(Prevention & Control of Pollution) Act, 1974 and Air(Prevention & Control of Pollution) Act, 1981;

**Whereas**, 50% bid Amount to the tune of **Rs. 65.395 Lacs** and 2% Income tax to the tune of **Rs. 1,30,790/-** has been deposited by you in the shape of CDR No. **2887977** dated 25-06-2020 and DD No. **778097** dated 09-09-2020;

**Now**, therefore in view of the above and as per Rule 55(9) of these Rules, the Letter of Intent (LoI) is hereby issued with the direction to submit Approved Mining Plan, Environmental Clearance besides, deposition of remaining 50% bid amount & Consent to Operate within a period of 06 months, enabling this office to grant Mining Lease in your favour for extraction of minor minerals (River Bed Material) from the above said block. You shall not extract or allow extraction till the Mining Lease under rules is granted.

*This Letter of Intent (LoI) is provisional. This shall be further subject to obtaining any other NOC from stakeholder departments/ requirement/ any third party dispute/statutory clearance under any Law/Rules governing the subject. This is in supersession to this office LoI issued vide No. 5660-66 dated 12.09.2020.*
